### **Business Policies: 2024-2025**

- The full Application Fee is required before or on the day of the interview.
- All accepted applicants are responsible for paying the Entrance Fee and the School Development Fee, regardless of date of entering or withdrawing from the program. This amount is non-refundable.
- Tuition is due 10 business days after acceptance is issued. An invoice for this amount will be included with the applicant's Letter of Acceptance. Registration is considered complete only after all fees have been paid. The student's 1st day of school will be 5 days after invoice due date.
- Tuition Fee is charged annually to all students who attend TYIS. No refund for the term will be issued after a term has begun.
- Tuition for the upcoming school year is due within 2 business weeks upon acceptance, prior
  to the beginning of school in September. For applicants who are accepted after June 1<sup>st</sup>,
  tuition is due immediately upon acceptance.
- Tuition can be paid by a single payment or via installments. *Note: Tuition paid via installments is subject to an administration fee.* The due dates for installment payments are as follows:

- Applicants who enroll mid-term are responsible for payment of that term upon registration.
- Applicants who register during a mid-term period will be charged a prorated percentage of the tuition for that term.
- 10% Consumption tax will be charged on all costs.
- Students who withdraw before the end of the academic year will be refunded the tuition for the term in which they will not be attending. No refund will be issued for withdrawal from the school after a term has begun.
- In case of a sibling, the second child will receive a 10% discount from the tuition fee only. The third child will receive a 50% discount from tuition fee only.
- Payments in the amount of ¥50,000 or more must be paid through the bank transfer system to the following account
